The Package consists of 2 Lots as listed in the above and the Bidders may bid for one lot or multiple lots. The Bidder evaluation and qualification criteria of the bidding document. The contract award will be on an lot by lot wise basis.

3. Interested qualified eligible suppliers are invited to obtain a copy of the bidding documents free-of-charge from the address given below by submitting a written application. Except for the submission of a written application, there shall be no other conditions for obtaining the bidding documents.
  4. To be considered eligible and qualified a bidder must:
    - i) Have completed at least two contracts for supply of similar goods and services in the preceding 3 years of not less than 50% of the bid price in each contract.
    - ii) Have completed contracts with a total cumulative value equal to at least two times the value of the bid price in the preceding 2 years.
    - iii) Not be under any notice of disbarment issued by the Government or World Bank.
  5. Bids must be delivered to the address given below at or before **10.00 am at November 06, 2020**. Late bids will be rejected. Bids will be opened in public immediately thereafter at the address given below in the presence of the Bidders' representatives and the project's beneficiaries from the concerned local community who choose to attend shall be allowed to be present in person.
  6. The Purchaser shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated bid and is substantially responsive to the Bidding Documents, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.
  7. All bids must be accompanied by a **bid and performance securing declaration** as described in the bidding documents. Any bid not accompanied by one will be rejected as non-compliant.
